## ST Scholarships- Advertisement Notification


All eligible **Schedule Tribe (ST)** students domiciled in the UT of Jammu & Kashmir, desirous of availing post matric scholarship Scheme for the year 2025-26 are informed and directed to submit fresh/renewal application form on NSP portal through website/URL <https://scholarships.gov.in>. The last date for online submission of applications on NSP portal is 17<sup>th</sup> of September. At the time of submitting online application on NSP portal student must upload following documents on NSP portal:-


- Scan copy of original domicile certificate.
- Scan copy of original category certificate (ST) issued by competent authority.
- Scan copy of original income certificate of parents/guardian issued by concerned Tehsildar bearing no & date. In case if parent/guardian is Govt/Private employee, income certificate issued by Tehsildar along with salary certificate issued by concerned DDO.
- Fee receipt in original along with name of candidate, date, and class/semester duly sealed and signed by competent authority.
- Scan copy of mark sheet/promotion of the last qualified examination/semester.
- Scan Copy of undertaking in the form of affidavit as per the format prescribed on annexure A (attached with instant notification) attested by the executive/judicial Magistrate.

### Eligibility Criteria:

- The student should belong to scheduled Tribe (ST) Category and must be domicile of Jammu and Kashmir.
- Students should have passed matriculation or higher secondary or any higher examination from a recognised university or board of secondary education.
- The family income of the student from all sources should not exceed 2.50 lakh per annum.
- The student should have a valid account in scheduled bank linked/seeded with Aadhar and mobile number.
- The student should not be getting any other scholarship from any ministry of GOI/department or govt. of Jammu and Kashmir.

After submitting online application form on NSP portal student should submit hardcopy of application form along with self attested photocopy of all documents uploaded on NSP portal to Prof.Ashwani kumar, convener scholarship committee on any working day upto 17<sup>th</sup> of September,2025 .The students should carry original version of all documents uploaded on NSP portal at the time of submission of hardcopy of application form for verification at institutional level.
